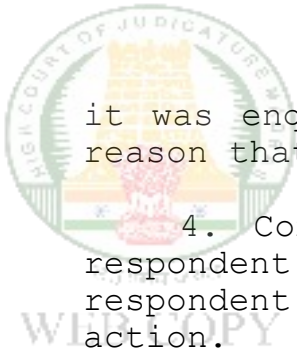

On the complaint lodged by the petitioner dated 20.09.2019, the third respondent has conducted enquiry with the fourth respondent and found that on the torture given by the family members of the fourth respondent, the present complaint has been lodged by the petitioner. In fact on the earlier complaint, dated 10.09.2019,



it was enquired by the third respondent police and closed for the reason that they themselves settled the dispute amicably.
