ORDER

This writ petition is filed for a direction to the respondents to consider the petitioner's representation dated 09.09.2019 and on that basis, to appoint the petitioner for the post of Technical Assistant by transfer in the vacant place at Madurai Electrical Sub Division, Madurai, on the basis of his educational qualification.

2.Mr.V.Anand, learned Government Advocate takes notice for the respondents. By consent of both parties, the Writ Petition is taken up for final disposal at the stage of admission itself.

Though various averments have been made in the writ petition, after elaborate arguments, the learned counsel appearing for the petitioner submitted that the petitioner would be satisfied, if a direction is issued to the second respondent to consider the representation of the petitioner, dated 09.09.2019.



4. Considering the submission of the learned counsel for the petitioner, without deciding the issue on merits in the writ petition, the second respondent is directed to consider the representation of the petitioner, dated 09.09.2019 and pass orders on merits and in accordance with law, within a period of twelve (12) weeks from the date of receipt of a copy of this order.

5. With the above direction, the writ petition is disposed of. No costs.
