2. Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor for the respondents.

Considering the above fact and circumstances of the case, the fourth respondent/Surveyor is directed to conduct survey, on the representations given by the petitioner, dated 03.10.2018 & 19.11.2018, after issuing notice to all the rival parties. If any hindrance is made out, the fourth respondent/Surveyor is directed to call adequate police protection from the respondent police. On receipt of the same, the respondent police shall consider the request on merits and in accordance with law.

4. With the above directions, this Writ Petition is disposed of. No costs.
