**Prayer in WP(MD) . 444/ 2013 :**

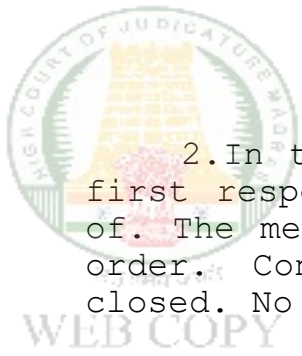
