2. This contempt petition is filed alleging willful disobedience of the order and directions issued in the writ



petition.

3. We find that the learned Writ Court has not issued any positive direction, but, directed the authorities to follow due process. We further find that the respondents 2 and 3 in the writ petition, who are said to be the alleged encroachers were not issued with notices when the writ petition was disposed of.

4. At this juncture, we cannot initiate contempt proceedings against the respondent. However, the District Collector, Dindigul District is directed to be comply with the directions issued by this Court, within a reasonable time not later than twelve weeks from the date of receipt of a copy of this order.

5. In the result, this contempt petition is closed.
