2.The learned Additional Government Pleader appearing for the second respondent submitted that the Well has been cleared and the debris has been removed and the cover over the Well has been erected.

3.The learned counsel for the petitioner submitted that some more cleaning is required. If any further cleaning is required, the same shall be done after inspecting the Well by one of the Officers. The Well shall be maintained clean. There should be no dumping of garbage.

4.With the above directions, the Writ Petition is disposed of. No costs.
