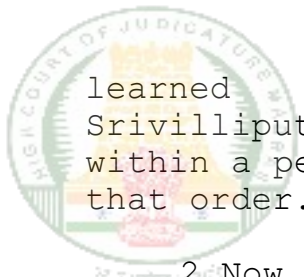

Prayer :-

This Petition filed Under Article 227 of the Constitution of India, to direct the Principal District Court, (Cooperative Tribunal) Srivilliputhur to dispose of the appeal CMA(CS) No.8/2016 as early as possible as per the time limit.

2.Now, the learned Judge has requested further time of two months to dispose of the above said case.

3.The request of the learned Judge is reasonable. Though the request is to grant further time of two months, in view of the outbreak of COVID-19, this Court grants eight months time from today to comply with the order of this Court, dated 22.11.2019.
