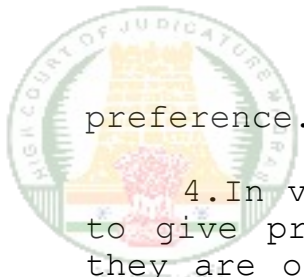

2.Challenge in this writ petition is a tender notification, issued by the first respondent, dated 31-10-2019, for the tender scheduled to be held on 14.11.2019.

3.According to the learned counsel for the petitioner, as per G.O.Ms.No.332, Animal Husbandry and Fisheries Department dated 17.11.1993, Co-operative Societies or Harijans shall be given



preference.

4.In view of the above, a direction is given to the respondents to give preference to the Co-operative Societies and Harijans, if they are otherwise eligible and willing to pay the competitive bid amount in respect of the bid, as per G.O.Ms.No.332, Animal Husbandry and Fisheries Department dated 17.11.1993.

5.With this observation, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
