2.Now, vide letter dated 01.09.2020, a request has been made by the learned Judicial Magistrate, Velliyoor, seeking extension of three months time, stating that due to lock down owing to COVID-19 pandemic situation, trial could not be conducted, within the time stipulated by this Court.



3.Considering the request made, time granted by this Court, vide order dated 03.09.2019, in Crl.O.P(MD)NO.2585 of 2017, is extended by three months from the date of receipt of a copy of this order. It is made clear that no further extension will be granted.
