PRAYER:- Writ Petition filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Mandamus directing the respondents to issue patta in favour of the petitioner pertaining to plot No.7B, Survey No.232/1A3, Ayanpappakudi Village, to an extent of 5 ½ cents vide registered sale deed in Doc.No.5437 of 2013 dated 24.05.2013 by cancelling the patta No.4123 which was issued based on the bogus and fabricated documents, based on the petitioner's representation dated 08.12.2015 and 24.04.2019.
