2.Today, when the matter is taken up for hearing, the learned Government Advocate (Crl. side) for the respondents would submit that the request of the petitioner has been conceded, however, since sufficient escorts are not provided by the Deputy Commissioner of Armed Reserved Force, the petitioner has not been sent. She would further submit that once requisite escorts are provided, the petitioner will be sent on leave to visit his ailing mother.
