Prayer in WP(MD). 20887/ 2017 :

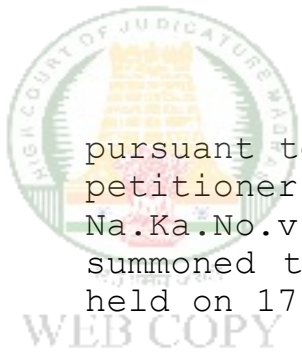
