2.The learned Additional Advocate General on instructions submitted that initially there was an order of stay restraining the authorities from conducting election to Primary Agriculture Co-operative Credit Societies, and the order of stay was vacated only on 15.07.2019 and effective steps are taken to conduct election at the earliest.

3.In the light of the above submission, there is no necessity to issue any direction as sought for in the writ petition. Accordingly, this writ petition is disposed of. No costs.
