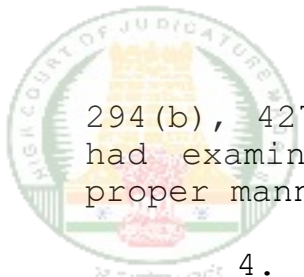
O R D E R

2. The learned counsel for the petitioner would submit that the petitioner's husband is working abroad and she was frequently harassed by one Rajan and thereby she fixed CCTV Camera around her house and the said Rajan along with other accused have damaged the CCTC camera, on respect of which a complaint has been given to the third respondent police. He would also submit that the third respondent is not conducting the investigation in a proper manner and thereby would seek for transfer of investigation.

3. The learned Government Advocate(Crl.Side) would submit that based on the complaint given by the petitioner a case in Crime No. 532 of 2019 has been registered for offences under Sections 109,
