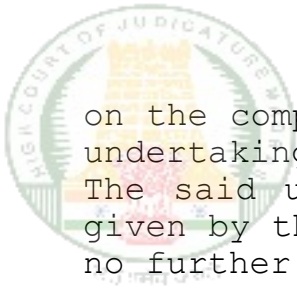
ORDER

2.Today, when the matter is taken up for hearing, the learned counsel for the petitioner would submit that in respect of the threat and harassment made by the respondents 3 to 6, the petitioner has given a complaint, seeking for police protection.

3.At this juncture, the learned Government Advocate (Crl. side) would submit that all the respondents were called for enquiry, based
