PRAYER IN Crl.RC (MD) SR.No.8086 of 2019

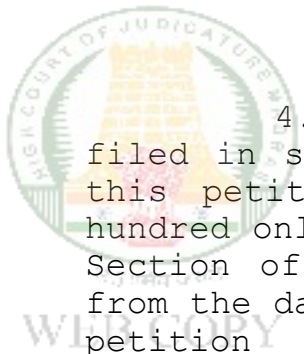
