ORDER

2.Heard, the learned counsel appearing for the petitioner and Mr.A.Muthukaruppan, learned Additional Government Pleader appearing for respondents. By consent of both parties, this writ petition is taken up for disposal at the admission stage itself.

3.In the representation, the petitioner and others have requested the second respondent to cancel the patta in respect of plot Nos.48 and 49 on the ground that the original allottees have alienated the plots illegally in violation of the conditions of the assignment.

4.Having regard to the nature of allegations, the petitioner is advised to file a public interest litigation as he wants take action for cancellation of assignment for violation of conditions of assignment. The petitioner has no personal interest or suffered legal injury on account of violation of condition of assignment by a
