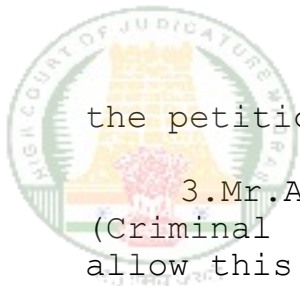
PRAYER IN CRL RC(MD)No.101 of 2019:
