ORDER

In view of the various pronouncements of the Division Bench of this Court observing that the High Court cannot be a forum to order for retest and also taking note of the fact that the petitioner's height was duly measured and arrayed at 167 c.m., during the



recruitment test, this Court is not inclined to entertain the prayer sought for in this writ petition.

2. However, if the petitioner is of the view that the original measurement was not properly taken, it is always open to the petitioner to cross-check the same, by making an appropriate application under the Right To Information Act [RTI], seeking for video recording of the measurement taken and on viewing such recording, if the petitioner is of the view that he is qualified in the physical measurement, it is open to the petitioner to redress his grievances, in a manner known to law.

3. Accordingly, this Writ Petition stands closed. No costs. Consequently, connected Miscellaneous Petition is closed.
