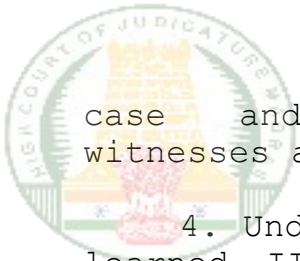

This petition has been filed seeking direction to expedite the trial in S.C.No.95 of 2017 and S.C.No.96 of 2017 pending on the file the learned II Additional District and Sessions Judge (PCR Court), Tirunelveli.

2. The learned counsel for the petitioner would submit that the petitioner is an accused and he is facing trial for the offences under Sections 417,376, 506(i) of IPC r/w.Section 3(1)(w)(i) of SC/ST Act. She would also submit that the case is pending from the year 2017 and prays to dispose of the case as expeditiously as possible

3. The Additional Public Prosecutor would submit that both the case are taken under common trial and there are 37 witness in this



case and the case is posted for the examination of official witnesses alone.
