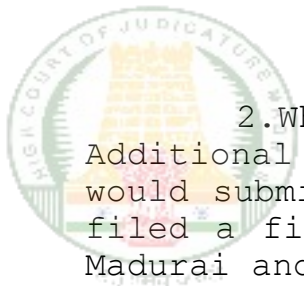
Prayer in CRL OP(MD). 1548/ 2018 :
