Prayer: Contempt Petition filed under Section 11 of the Contempt of Courts Act, 1971, to punish the contemnor/3rd respondent for willfully and deliberately disobeying the order passed by this Court made in W.M.P.(MD) No.12094/2018 in W.P.(MD) No.13261/2018 on 21.06.2018.

Prayer in WMP(MD). 12094/ 2018 :

To grants an order of interim injunction restraining the respondents from filing up of the post of P.G.Assistant Zoology issues at Maruthakulam Government Higher Secondary School, Tirunelveli District pending disposal of the above Writ Petition.

Prayer in WP(MD). 13261/ 2018 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus to call for the entire records pertaining to the impugned Government Order in G.O.(1D) No.403 dated 29/05/2018 on the file of the 1st respondent and quash the same as illegal in so far as Condition No.17 and consequently direct the respondents to appoint the petitioner as P.G.Assistant Zoology at Maruthakulam Government Higher Secondary School, Tirunelveli District.
