Prayer in WP(MD) . 13980/ 2018 :

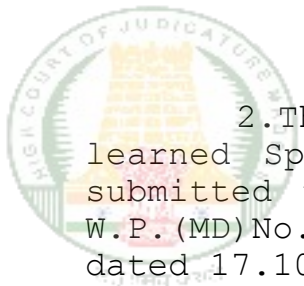
