Prayer : Petition filed under Section 11 of the Contempt of Courts Act, 1971, to punish the respondents for their wilful, disobedience of the order passed by this Court, dated 23.08.2016, in W.P.(MD)No.14782 of 2016.

Prayer in WP(MD). 14782/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the 1st respondent to pay the petitioner Rs.6,23,726/- towards Gratuity Rs. 2,38,469/- towards Leave Salary Rs. 4,360/- towards refundable deposits and also arrears of wages for the period from 01.09.13 to 31.03.2015 payable pursuant to new wage settlement dated 13.04.2015 together with 18% interest per annum, along with inters amount towards the delayed payment of EPF Employees Contribution amount Rs, 2,90,921/- for the period from 31.03.2016 to 24.09.2016 at the rate as per EPF Scheme and further directing the respondents to pay him Rs.2,59,468/- towards the pension commutation amount together with 18% interest per annum within a time frame.
