Prayer: Contempt Petition is filed under 11 of the Contempt of Courts Act, 1971, to punish the respondents for willfully disobeying and not complying with the order of this Hon'ble Court, dated 11.11.16 in W.P.(MD)No.21700/2016.

Prayer in WP(MD). 21700/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the 1st respondent to pay the petitioner Rs.10,00,203/- towards Gratuity, Rs.3,39,400/- towards Leave Salary, Rs.25,000/- towards Social Security scheme benefit and Rs.5,000/- towards Refundable Deposits, together with 18% interest per annum, along with interest amount towards the delay in paying EPF Employees Contribution amount Rs.3,21,595/- for the period from 31.08.16 to 21.09.17 at the rate as per EPF Scheme and further directing the respondents to pay him Rs.3,68,860/- towards the pension commutation together with 18% interest per annum within a timeframe as may be fixed by this Court.
