Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Mandamus directing the 1st respondent to pay the petitioner Rs.9,10,693- towards Gratuity, Rs.7,59,119/- towards E.P.F Employees Contribution and Rs.3,36,068/- towards Leave Salary, together with 18% interest per annum and further directing the respondents to pay him Rs.3,35,610/- towards the pension Commutation, together with 18% interest per annum, within a time frame as may be fixed by this Court.
