3.The learned Government Advocate appearing for the Official respondents submitted that thorough survey has been conducted by the Revenue Officials and it has been ascertained that there is an encroachment and the authorities are in the process of issuance of Form-1 and subsequently, Form-II and Form-III.

4.In the light of the above, we direct the authorities to proceed in accordance with law, after notice to the sixth respondent. No costs.
