Prayer in WP(MD) . 2975/ 2016 :

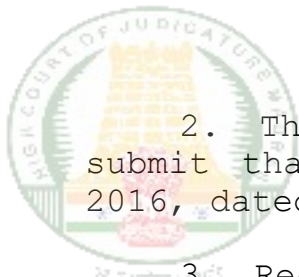
