2. That there be and hereby no costs in this Second Appeal.

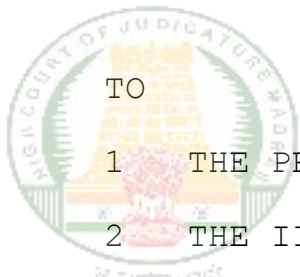
