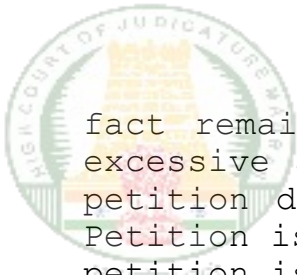

The learned counsel appearing for the fourth respondent made a statement that the order of punishment issued by the School Management was not proved by the competent authorities with reference to the provisions of the Tamil Nadu Recognized Private Schools (Regulation) Act.
