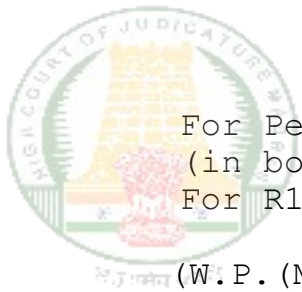

PRAYER (in W.P.(MD) No.9570 of 2013): Writ Petition filed under Article 226 of the Constitution of India for issuance of writ of certiorarified mandamus calling for the records relating to the order of the first respondent 1D(No.).341 Higher Education (C1) Department, dated 05.12.2012, quashing the same and directing the second respondent to reconsider the petitioner's appointment as Lecturer in Mathematics in the third respondent college with effect from 23.01.2008 the date of the petitioner appointment.
