Heard both sides.

Having regard to the facts and circumstances of the case and taking into consideration the fact that the petitioner has been reporting before the S.H.O., Raikal Police Station from the date of his release, the order directing the petitioner to report before the S.H.O., Raikal Police Station, on every Wednesday and Sunday is modified and the petitioner is directed to report before the said S.H.O. on every Sunday. The other conditions in the order shall remain un-altered.

Accordingly, the I.A. is disposed of.
