Petition under Sections 437 & 439 of Cr.P.C, praying that in the circumstances stated in the affidavit filed in support of the Criminal Petition, the High Court may be pleased to enlarge the Petitioner on Bail in Crime No. 1/2019 on the file of Boinpalli Police Station, Rajanna Siricilla District for the Offence U/Sec. 143, 147 324 r/w 149 IPC., Sec.3 (1) (r) (s) of SCs/STs (POA) Amendment Act, 2015

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of MR.TERA RAJINIKANTH REDDY Advocate for the Petitioner and of the ADDITIONAL PUBLIC PROSECUTOR (TG) for the Respondent, the Court made the following.

ORDER

This Criminal Petition, under Section 439 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A.2, for grant of bail in Crime No.1 of 2019 of Boinpalli Police Station, Rajanna Siricilla District, registered for the offences punishable under Sections 143, 147, 324 read with 149 of IPC and Section 3(1)(r)(s) of the Scheduled Castes and Scheduled Tribes (PoA) Amendment Act, 2015 (for short 'the Act').

2. Heard the learned counsel for the petitioner/A.2, the learned Additional Public Prosecutor representing the respondent/State and perused the record.

3. The petitioner/A.2 was remanded to judicial custody on 01.01.2019. This is a regular bail application. The material witnesses are examined. Under these circumstances, the petitioner/A.2 can be granted bail under Section 439 Cr.P.C. on some conditions.

4. Accordingly, the petitioner/A.2 is ordered to be released on bail on his executing a personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties in a like sum each to the satisfaction of the Judicial First Class Magistrate, Vemulavada. After release on bail, the petitioner/A.2 shall report before the Station House Officer, Boinpalli Police Station, Rajanna Siricilla District, on every Sunday between 09:00 A.M. and 10:00 A.M. till filing of the charge sheet.

5. The Criminal Petition is, accordingly, allowed.
