Petition under Section 437 & 439 of Cr.P.C, praying that in the circumstances stated in the affidavit filed in support of the Criminal Petition, the High Court may be pleased too enlarge the petitioner on bail in Crime No. 343/2018, dt.13/12/2018 U/s. 420 and 409 of IPC on the file of the Adilabad-II Town Police Station, Adilabad

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof upon hearing the arguments of R MANGULAL Advocate for the Petitioner and the PUBLIC PROSECUTOR for the Respondent, the Court made the following.

ORDER:

This Criminal Petition, under Section 439 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A.1, for grant of bail in Crime No.343 of 2018 of Adilabad II Town Police Station, Adilabad District, registered for the offences punishable under Sections 420 & 409 of IPC.

2. Heard the learned counsel for the petitioner/A.1, the learned Additional Public Prosecutor representing the respondent-State and perused the record.

3. In the course of submissions, it is brought to the notice of this court that A.3 and A.4 in this crime were granted regular bail by the Special Judge for trial of Cases under SCs/STs (POA) Act-cum-V Additional District and Sessions Judge, Adilabad, vide order, dated 13.03.2019, passed in CrI.M.P.No.190 of 2019. This petitioner/A.1 was remanded to judicial custody on 11.01.2019. The offences alleged against him are under Sections 420 & 409 of IPC. Material witnesses are examined and most part of the investigation is completed. Under these circumstances, the petitioner/A.1 can be granted bail under Section 439 of Cr.P.C.

4. Accordingly, the petitioner/A.1 is ordered to be released on bail on his executing a personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties in a like sum each to the satisfaction of the learned Judicial Magistrate of First Class, Adilabad. On such release, the petitioner/A.1 shall report before the Station House Officer, Adilabad II Town Police Station, Adilabad District, on every Sunday between 09:00 AM and 10:00 AM, till filing of the charge-sheet.

5. The Criminal Petition is, accordingly, allowed.
Miscellaneous petitions, if any, pending in this Criminal Petition, shall stand closed.
