The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof upon hearing the arguments of INDIRA Advocate for the Petitioners and the PUBLIC PROSECUTOR (TG) Advocate for the Respondent, the Court made the following.

ORDER:

The petitioners, accused Nos.1 and 2 in Crime No.21 of 2019 on the file of Edulla Bayyaram Police Station, Bhadradri-Kothagudem District, which was registered under Section 306 IPC, seek anticipatory bail under Section 438 Cr.P.c.

Learned Assistant Public Prosecutor, State of Telangana, would inform this Court that 8 witnesses were already examined and the F.S.L. report is awaited. He would further state that if the petitioners/accused Nos.1 and 2 cooperate with the investigation, they may be enlarged on anticipatory bail at this stage subject to conditions.

Given the aforestated facts, this Court is of the opinion that this is a fit case for grant of anticipatory bail subject to some conditions being imposed.

The Criminal Petition is accordingly allowed. In the event the petitioners, accused Nos.1 and 2 in Crime No.21 of 2019 on the file of Edulla Bayyaram Police Station, Bhadradri-Kothagudem District, are arrested, they shall be enlarged on bail upon their furnishing a personal bond for a sum of Rs.10,000/- (Rupees Ten thousand only) each along with two sureties for a like sum each to the satisfaction of the Station House Officer, Edulla Bayyaram Police Station, Bhadradri-Kothagudem District. The petitioners shall abide by the conditions prescribed in Section 438 (2) Cr.P.C.
