Petition under Sections 437 & 439 of Cr.P.C. praying that in the circumstances stated in the petition filed herein, the High Court may be pleased to grant bail to the Petitioner by directing his release in SC No. 97 of 2017 on the file of the Metropolitan Sessions Judge Cyberabad at LB Nagar for a Limited period, on such terms and condition as this Court deems fit and proper in the interest of Justice.

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and upon hearing the arguments of Sri K SURENDER, Advocate for the Petitioner, and of V GOPALAKRISHNA GOKHALEY, Spl. Public Prosecutor for the respondent, the Court made the following.

**CRIMINAL PETITION No.2343 OF 2019**

**ORDER:**

1 The petitioner, A.3 in S.C.No.97 of 2017 on the file of the Metropolitan Sessions Judge, Cyberabad at L.B Nagar, seeks regular bail under Sections 437 and 439 CrPC on the ground that his grandmother is on her death bed.

2 Sri Gopalakrishna Gokhale, learned Special Public Prosecutor for the Narcotics Control Bureau, would inform this Court that the claim made by the petitioner /A.3 as to the ailing health of his grandmother is correct and concedes that he may be permitted to visit her on interim bail subject to conditions.

3 The Criminal Petition is accordingly allowed. The petitioner /A.3 shall be released on interim bail for a period of three days to enable him to visit his ailing grandmother, who is stated to be in Siddipet town, with a special escort provided by the Jail Personnel of Cherlapally Central Prison. The petitioner /A.3 shall also furnish a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) along with two sureties each for a like sum to the satisfaction of the learned Metropolitan Sessions Judge, Cyberabad at L.B Nagar in this regard. Upon the return of the petitioner / A.3, the personal bond and the sureties shall stand discharged.
