Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent authorities to forthwith issue the appointment orders to the petitioners for the post of Junior Panchayat Secretary in Mahabubnagar District, in terms of the Provisionally Selected List by treating her as local candidate of Mahabubnagar District, or alternative keep one post of Junior Panchayat Secretary in Mahabubnagar District vacant, pending disposal of the main Writ Petition No.14334 of 2019, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following (The receipt of this order will be deemed to be the receipt of notice in the case)

ORDER:

Since the petitioner has studied in the composite District of Mahabubnagar, which was subsequently bifurcated into five new Districts, the benefit of studying in the combined District of Mahabubnagar cannot be denied. As such, the case of the petitioner that she is a local candidate of newly formed Districts has to be considered.

Therefore, the respondents are directed to consider the case of the petitioner for appointment to the post of Junior Panchayat Secretary by treating her as a local candidate of Mahabubnagar District, irrespective of the fact whether she has studied in newly formed Nagarkurnool District area or not.
