COMMON ORDER:

Limited grievance of the petitioners in all these writ petitions is, aggrieved by the decision of granting pattadar pass books in favour of 4th respondent in respective Writ Petitions on land to an extents mentioned in the table below, revision petitions are filed before the Joint Collector.
