This appeal has been filed under Section 260A of the Income Tax Act, 1961 (for short 'the Act') against the order of the Income Tax Appellate Tribunal, Delhi Benches "Friday-D" New Delhi in Stay Application No.340/Del/2018 (arising out of ITA No. 2403/Del/2017) dated 18.05.2018 for the Assessment Year 2008-2009.
