Application has been filed under Section 151 CPC for
condonation of delay 65 days in re-filing the above-cited appeal.

In view of the averments made in the application which is duly

supported by affidavit of the counsel, sufficient cause is made out. The

application is accordingly allowed and the delay of 65 days in re-filing the appeal is condoned.

CM stands disposed of.

CM-1162-CI-2019

Application under Section 5 of the Limitation Act has been filed for condonation of delay of 1734 days in filing the above-cited appeal.

Keeping in view the averments made in the application which is duly supported by affidavit, the delay of 1734 days in filing the appeal is condoned conditionally in view of the judgment of the Apex Court in *Imrat Lal & others Vs. Land Acquisition Collector & others 2015 (2) RCR (Civil) 437* and *Dhiraj Singh (deceased) through LRs Vs. Haryana State & others 2015 (2) RCR (Civil) 507*, as interest of the State can be protected by denying the interest for the period of delay. It is made clear that the appellants shall not be entitled to interest for the said days on the enhanced compensation in case the appeal is allowed.
