Present application under Section 407 of the Code of Criminal Procedure read with Section 142 of Negotiable Instruments Act, 2015 (Amended), is for transfer of Complaint Cases Nos.COMA/3006, 3065, 3066/2015, titled as 'M/s Gurdas Agro Pvt. Ltd. vs. M/s Arjun Mall Retail Holding Pvt. Ltd. and others' pending in the Court of Judicial Magistrate Ist Class, Ludhiana and the Complaint Case No.COCP/89/2016, titled as 'Sharan Dass vs. M/s Arjun Mall Retail Holding Pvt. Ltd. and others' pending in the Court of Judicial Magistrate Ist Class, Bathinda, to one and the same Court having competent jurisdiction either at Bathinda or at Ludhiana.

Power of Attorney filed on behalf of respondent No.1 is taken
on record.

Learned counsel representing respondent No.1 submitted that respondent No.1 has no objection if all the cases are transferred at one place.

Having considered the submissions made by learned counsel for the parties and in view of the grounds mentioned in the application and in the interest of justice, the abovesaid Complaint Cases bearing Nos.COMA/3006, 3065, 3066/2015, titled as 'M/s Gurdas Agro Pvt. Ltd. vs. M/s Arjun Mall Retail Holding Pvt. Ltd. and others' are withdrawn from the Court of Judicial Magistrate Ist Class, Ludhiana and are transferred to the Court at Bathinda. Parties shall appear before learned District and Sessions Judge, Bathinda on 27.03.2019, who will transfer these cases to the Court, having competent jurisdiction in the matter, where Complaint Case No.COCP/89/2016, titled as 'Sharan Dass vs. M/s Arjun Mall Retail Holding Pvt. Ltd. and others' is pending.

In view of above, the present application stands disposed of.
