RAJ SHEKHAR ATTRI, J. (Oral)

By invoking Section 482 of the Code of Criminal Procedure (in short 'Cr.P.C.'), the petitioner has prayed for quashing of FIR No. 56 dated 04.05.2018 (Annexure P-1) for offences punishable under Sections 363 and 366-A of the IPC, registered at Police Station Chabbewal, District Hoshiarpur along with all consequential proceedings emanating therefrom, on the basis of the compromise dated 01.02.2019 (Annexure P-2).

In the present case, the FIR was registered on the statement of respondent No. 2/complainant Pardeep Kaur wife of Ashok Kumar. Now, the dispute between the parties has been resolved by way of compromise dated 01.02.2019 (Annexure P-2).

Vide order dated 11.02.2019, the parties were directed to appear before the trial Court to get their statements recorded with regard to genuineness of compromise.

Pursuant thereto, a report has been submitted by Judicial

Magistrate First Class, Hoshiarpur, wherein it has been reported that statements of the parties have been recorded and they have voluntarily compromised the matter without any coercion or undue influence.

Counsel for the State as well as counsel for respondent Nos. 2 and 3 have not disputed that the parties i.e. petitioner and respondent Nos. 2 and 3 have arrived at a settlement with an intent to give burial to their differences.

Perusal of allegations in the FIR reveals that the present case squarely falls in the category of cases that can be quashed by the High Court, in exercise of its inherent power under Section 482 Cr.P.C. Keeping in view authoritative enunciation of law laid down by Hon'ble Supreme Court in '**Gian Singh vs. State of Punjab and another**', 2012 (4) R.C.R. (Criminal) 543 and in the light of facts and circumstances discussed hereinbefore, this Court is of the considered opinion that continuation of criminal proceedings would amount to abuse of process of law and it is expedient in the interest of justice that the same are put to an end.

For the foregoing reasons, the petition is allowed and FIR No. 56 dated 04.05.2018 (Annexure P-1) for offences punishable under Sections 363 and 366-A of the IPC, registered at Police Station Chabbewal, District Hoshiarpur and all the proceedings emanating therefrom stand quashed qua the petitioner.
