JITENDRA CHAUHAN, J.

This writ petition under Articles 226/227 of the Constitution of India has been filed for issuance of direction to respondent No.2 to remove respondent No.5 from the post of Sarpanch as he is in illegal possession of panchayat land bearing Khasra No.387.

Learned counsel appearing on behalf of the petitioner states that at this stage, he would be satisfied, if a direction is issued to respondent No.2 - Deputy Commissioner, Karnal to consider and decide the legal notice dated 7.1.2019 (Annexure P-7) expeditiously.

Heard.

A complete set of paper book has been handed over to Mr.Vikrant Pamboo, DAG, Haryana in the Court today.

In view of the above, without adverting to the merits of the

case, the present petition is disposed of with a direction to respondent No.2 -Deputy Commissioner, Karnal to consider and decide the legal notice dated 7.1.2019 (Annexure P-7) within six weeks from the receipt of the certified copy of the judgment after giving an effective opportunity of hearing to the petitioner. In case, on consideration, the competent authority reaches to the conclusion that the benefit claimed by the petitioner is admissible to him, in such eventuality, the consequential relief be allowed to him, within a period of six weeks thereafter. However, in case the competent authority feels that the relief claimed by the petitioner is not admissible or made out, in that case, a speaking order be passed in the matter.
