TEJINDER SINGH DHINDSA, J. (ORAL)

Instant writ petition has been filed assailing the order dated 21.01.2019 (Annexure P-11) passed by the respondent/CBSE and whereby request of the petitioner seeking correction of father's name of the petitioner from Parwinder Singh to Parwinderpal Singh in the matriculation certificate has been declined.

Notice was issued in the writ petition.

Mr. Kannan Malik, Advocate has entered appearance on behalf of the respondents and states that he does not wish to file reply.

In view of the above, this Court has proceeded further in the matter and has heard counsel for the parties.

Perusal of the impugned order at Annexure P-11 would reveal that the request of the petitioner seeking correction as regards father's name in the 10th Class certificate has been declined on the basis that the school record does not support the correction prayed for.

Appended along with the petition at Annexure P-1 is the

admission form of the school in question i.e. B.S.T. Senior Secondary School, Village Beharipur, District Kapurthala, Punjab. Likewise at Annexure P-3 is the relevant extract of the admission and withdrawal register of the School. A conjoint reading of the admission form at Annexure P-1 and admission/withdrawal register at Annexure P-3 would make it clear that as per school records, the father's name of the petitioner stands recorded as Parwinderpal Singh and not Parwinder Singh.

Learned counsel representing the respondent/CBSE does not dispute the contents of the documents at Annexure P-1 as also P-3.

In view of the above, the very basis of passing of the impugned order at Annexure P-11 does not exist.

This Court would have no hesitation in observing that the request of the petitioner seeking correction as afore noticed has been rejected by the CBSE by passing the impugned order dated 21.01.2019 (Annexure P-11) against the record.

Resultantly, the instant petition is allowed.

Order dated 21.01.2019 (Annexure P-11) is set aside.

Directions are issued to the respondent/Board to issue in favour of the petitioner a fresh 10th Class certificate incorporating the name of the father as Parwinderpal Singh instead of Parwinder Singh.

Needful be done within a period of two weeks from the date of receipt of a certified copy of this order.

Writ petition is allowed in the aforesaid terms.
