MAHABIR SINGH SINDHU, J.(Oral)

Present petition has been filed under Section 482 Cr.P.C for quashing of FIR No.297 dated 21.06.2018(P-1), under Sections 406 and 420 of the Indian Penal Code, registered at Police Station Sushant Lok, District Gurgaon (Gurugram) as well as all other consequential proceedings arising therefrom.

On instructions from Inspector Jasbir Singh, learned State counsel has apprised the Court that petitioners were declared proclaimed offenders on 24.10.2019 and thus they have no respect for law.

Reply by way of affidavit of Karan Goel, HPS, Assistant Commissioner of Police, DLF, Gurugram, already filed in the Registry on behalf of respondent No.1, is taken on record. Registry to tag the same at appropriate place.
