GURVINDER SINGH GILL, J.(Oral)

The petitioners have approached this Court seeking quashing of FIR No.64 dated 14.6.2017 registered at Police Station Kotbhai, District Sri Muktsar Sahib under Sections 323, 341, 148 and 149 of Indian Penal Code, 1860, wherein offence under Section 325 IPC was added later on vide DDR No.25 dated 24.6.2017 and all subsequent proceedings emanating therefrom on the basis of a compromise having been effected between the parties.

Vide order dated 27.5.2019, the parties had been directed to appear before the Illaqa Magistrate/trial Court so as to get their statements recorded qua the factum of compromise.

Report of learned Judicial Magistrate 1st Class, Gidderbaha has been received, wherein it has been reported that statements of

petitioners/accused Gurdeep Singh, Kapoor Singh, Sulakhan Singh, Gatti Singh @ Godi Singh @ Gurmeet Singh, Jindu Singh @ Harjinder Singh, Baljinder Singh, Mandar Singh, Gurcharan Singh and Kala Singh @ Gurmeet Singh and also of complainant Balvir Singh and Mahinder Singh have been recorded to the effect that they have compromised the matter amongst themselves and they have no objection in case the FIR is quashed.

The learned Judicial Magistrate 1st Class, Gidderbaha has specifically opined that the parties have entered into compromise voluntarily without there being any pressure, coercion or undue influence.

In view of the aforesaid compromise and bearing in mind the law laid down by Full Bench of this Court in 2007(3) RCR (CrL.) 1052 Kulwinder Singh and others Vs. State of Punjab, the present petition is allowed and FIR No.64 dated 14.6.2017 registered at Police Station Kotbhai, District Sri Muktsar Sahib under Sections 323, 341, 148 and 149 of Indian Penal Code, 1860, wherein offence under Section 325 IPC was added later on vide DDR No.25 dated 24.6.2017 and all subsequent proceedings emanating therefrom are hereby quashed qua petitioners.
