The petitioner filed the present petition for issuance of writ in the nature of Habeas Corpus for directing respondents No. 2 and 4 to produce the detenue namely Harpreet Kaur alleged to have been illegally detained by respondents No. 5 to 8.

Detenue Harpreet Kaur has appeared in the Court and stated that she has not been illegally detained by any of the private respondents and she is living in Gurugram, Haryana as per her own free will.

On being questioned by the Court, detenue-Harpreet Kaur has stated that she performed marriage with the petitioner and also filed petition before this Court for protection of her life and liberty. She is self dependent person and living in Gurugram, Haryana and completing her studies. She does not want to go with the petitioner. She has not been illegally detained by anyone of the private respondents and is living in Gurugram, Haryana out of her own free will. Statement of the detenue has been recorded in this

regard separately.

The detainee-Harpreet Kaur has thereafter stated that she wants to file an affidavit.

Case to come after sometime for filing of the affidavit, if any, so desired.
