The present petition has been filed under Section 439 Code of Criminal Procedure (in short, “Cr.P.C”.) for grant of regular bail to the petitioner in case FIR No.340 dated 12.11.2017 registered for the offences punishable under Sections 363, 366-A, 376, 120-B of Indian Penal Code and Sections 3 & 4 of Protection of Children from Sexual Offences Act at Police Station Sultanpur Lodhi, District Kapurthala.

Heard.

This Court would like to reproduce the relevant part of the FIR as under : -

“....on 10.11.2017 I was present alone at my house and Gurpreet Singh son of Harcharan Singh caste Jat came at our house at about 10 p.m. and he told me that his mother is calling

you, and when I came out from my house into the street found Paramjit Kaur wife of Harcharan Singh caste Jat resident of Dhundianwal, PS Sultanpur Lodhi, Kapurthala and Kulbir Kaur @ Baby wife of Gurjeet Singh caste Jat resident of Fatehpur, PS Shahkot, District Jalandhar standing there and asked me to come with us to our house and on my refusal both hold me from my arms and forcibly took me to their house, where Harcharan Singh son of Amar Singh caste Jat resident of Dhundianwal, PS Sultanpur Lodhi was also present in house where I was forcibly pushed in a room along with Gurpreet Singh by Paramjit Kaur, Kulbir Kaur @ Baby and Harcharan Singh and bolt the room from outside, Gurpreet Singh have committed rape with me without my consent, I raised Rolla but no one has listen to me and when in morning when I came out after opening the door by them, then my mother Manjit Kaur and father Sukhwinder Singh came at the house of Gurpreet Singh while searching me then Paramjit Kaur and Kulbir Kaur @ Baby told to my parents that she is daughter-in-law of this house and we will not send with you. Gurpreet Singh earlier also committed rape with me by threatening me and after raped me he told me that if you tell anybody then I will kill you and your father and I due to fear have not tell anything to my parents....”

Trial is in progress and statement of the prosecutrix has been recorded.

regular bail to the petitioner.

Dismissed.
