This order shall dispose of above said 21 contempt petitions.

These contempt petitions have been filed pleading wilful

disobedience of order dated 27.03.2018 passed in bunch of writ petitions.

The writ petitions were allowed in terms of *CWP No. 20139 of 2015* titled as *Chiman Singh Versus Punjab State Power Corporation and others* decided on 29.02.2016.

The respondent preferred LPAs and the same were dismissed.

Learned counsel for the respondents, on instructions from Sh. Jiwan Kumar, Dy. CE., PSPCL, Bathinda states that the respondents are in process of filing SLP, however, in the meantime, directions of this Court will be complied with subject to the outcome of the SLP. He further states that needful shall be done within a period of six weeks from today and the orders would be communicated to the petitioners.

In view of the above, all the petitions are disposed of as infructuous. The petitioners would be at liberty to revive the contempt petition, in case, the statement made by learned counsel for the respondents today in Court is not adhered to.

It is further clarified that in case, the petitioners are forced to revive the contempt petition, exemplary costs may be imposed which shall be recovered personally from the defaulting official.

Rule issued against the respondents stand discharged.
