Learned counsel for the petitioners contends that he is pressing this petition qua petitioner No.1 and wants to withdraw the petition qua petitioners No.2 and 3.

The petition qua petitioners No.2 and 3 is dismissed as withdrawn.

Petitioner No.1, who is an under-trial in case FIR No.110 dated 18.09.2017 under Sections 148, 149, 302, 307, 323, 452 and 506 of the Indian Penal Code and Section 25 of the Arms Act registered at Police Station Kheri Pul Faridabad, is seeking interim bail to enable him to perform the ceremonies in connection with the marriages of his daughter Sakshi and son Lalit Sharma, which are stated to be performed on 07.05.2019 and 17.05.2019, respectively.

Learned State counsel, upon instructions from SI Silak Ram, states that the marriage of the daughter and son of petitioner No.1 is indeed

slated for 07.05.2019 and 17.05.2019, respectively, and the trial Court had already granted interim bail to him for one day each to attend the ceremonies.

Learned counsel for petitioner No.1 contends that a day would not be sufficient to enable petitioner No.1 to make arrangements for the marriage of his children.

The marriage of the daughter and the son of petitioner No.1 is to be performed on 07.05.2019 and 17.05.2019, respectively, and it would be in the interest of justice if petitioner No.1 is granted interim bail for sufficient time to make arrangements and perform ceremonies in connection with the marriage of his children.

Consequently, the petition qua petitioner No.1 is allowed. Petitioner No.1 shall be released on interim bail at 06:00 p.m. today itself, i.e. 06.05.2019, and he shall surrender before the Superintendent, District Jail, Faridabad on 08.05.2019 at 05:00 p.m. He shall thereafter be released at 09:00 a.m. on 15.05.2019 and he shall surrender before the Superintendent, District Jail, Faridabad, on 18.05.2019 at 05:00 p.m. He shall remain in police custody during the period of interim bail. The Superintendent, District Jail, Faridabad and the Commissioner of Police, Faridabad shall make necessary arrangements in this regard at the cost of the petitioner.
